2019 was a record year for FIGS of Wake County. We reached a new milestone in partnerships and provided over 20,000 prescriptions for 5,711 Wake County residents.

That's a testament to the dedication and compassion of our partners, financial supporters, volunteers, and board. It hasn't always been easy. We've asked more from our supporters than ever. But the result that effort is undeniable.

In 2019 our board created a plan to grow the number of partners who deliver our programs in Wake County. I am pleased to announce that in addition to Urban Ministries and Alliance Medical Ministry, we now have two new prescription voucher partners:

- Dorcas Ministries
- NeighborHealth Center of Raleigh

Moreover, our services expanded from the prescription voucher program to providing direct medical services via our third new partner, the UNC School of Nursing Mobile Health Unit.

Your donations funded:

- prescription medications
- over-the-counter medications,
- flu shots,
- asthma inhalers.
- smoking cessation supplies,
- diabetes testing supplies,
- endometrial testing supplies,
- C-Pap machines for sleep apnea, and
- transportation to medical appointments.

Our ongoing goal is to keep our overhead low while increasing our services in Wake County, and you truly make this possible! FIGS is stronger than ever due to our expanding community who comes together to donate time, resources, and talent in support of our important mission.

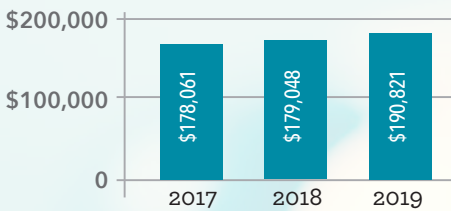

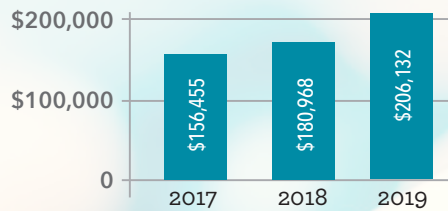

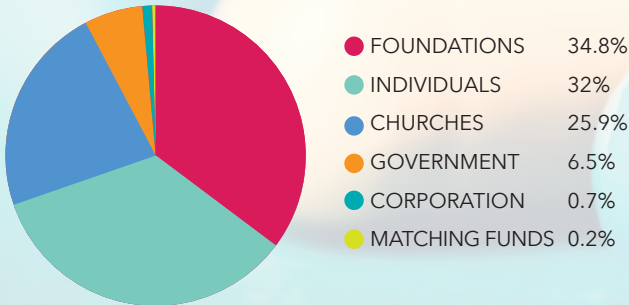
### 2017-19 REVENUE



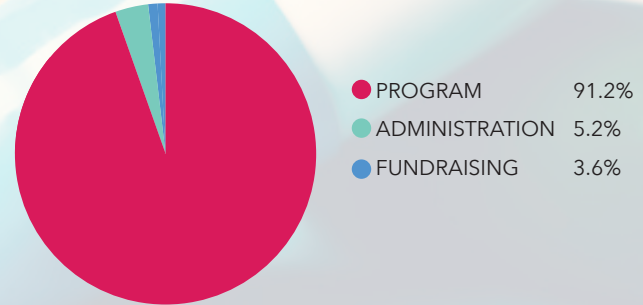
### 2017-19 EXPENSES
